### 20-e004: Parish Council Finance

- a. Remedial work for the overflow car park area. Cllr J Biddlecombe presented a quote for remedial work in the overflow car park to repair damage to the existing scalping surface where there were large potholes and problems at the corner caused by cars passing each other and overshooting onto the grass. The quote also included work to re-surface the area to the right of the yellow gate. After some discussion, it was proposed by Cllr J Biddlecombe, seconded by Cllr G Sallis and RESOLVED to accept the quote from Test Valley Paving for £1,850.00 plus vat, and
- authorise remedial work for the overflow car park area.
- b. Installation of new multi-play equipment at Littleton playground. Cllr S Burgess shared a set of slides on the Zoom screen showing the problems with the existing Littleton playground multi-play equipment, and proposed a replacement from Playdale Playgrounds Ltd. Following a review of the costs, and consideration of the playground 2020-21 budget and the reserves position, it was proposed by Cllr S Burgess, seconded by Cllr J Biddlecombe and RESOLVED to accept the quote from Playdale Playgrounds Ltd. for £13,470 plus vat to install new play equipment in the Littleton playground.

Cllr J Biddlecombe presented the planning application for Waterman's Cottage, New Road, Littleton SO22 6QR. Concerns were expressed particularly with regard to proposals for the rear elevation and the visibility from the Littleton Recreation ground, and after a unanimous vote, **it was RESOLVED to object to the planning application.**
